

Terms and Conditions

Paralowie Village

Halloween Colouring Competition 2025

Key Terms:

Information on how to enter and win the prize form part of these conditions. By participating, entrants thereby acknowledge they have read, understood, and agree to these terms and conditions herein. Entries must comply with the conditions to be valid.

Eligible Entrants:

1. Entry is open to all permanent South Australian residents aged 15 years and younger and must have parent/caregiver permission.
2. Employees (and their immediate families) of the Promoter or retailers are not eligible to enter Paralowie Village Shopping Centre competitions.
3. Entrants may only enter once. Multiple entries are not permitted.

“The Promoter” is Paralowie Village Shopping Centre located at 3-7 Liberator Drive, Paralowie, SA 5108.

How To Enter:

1. Complete one of the eligible colouring sheets available at the mall or at our website and provide your child’s name, age and suburb.
2. Parents/Caregivers must provide their contact details on the back of the sheet.
3. Submit your completed sheet to a staff member at the Lotteries tenancy before the deadline.

Promotional Period:

The period is between 9:00am Monday 29th September to 9:00am 30th October 2025.

Prize Details:

1. The prize per winner is one (1) voucher redeemable at 48 Flavours Paralowie Village, each worth \$50 and there are two (2) winners. The total prize pool is two (2) vouchers worth \$50 each.
2. The prize (voucher) is not transferrable and cannot be redeemed for cash or anything else.
3. Winners will be picked out by a random name generator and no further correspondence will be entered into by Paralowie Village and its affiliates.
4. The eligible winner will be notified by phone and/or any other means the Promoter deems necessary, and upon contact made and eligibility confirmed, the winner will be announced on the Promoter’s Facebook page, Instagram and website.
5. Once mutual contact has been made with the winner, the winner will have 24 hours to collect their prize. If the winner does not collect their prize within this allocated time frame, it is at the discretion of the Promoter whether the winner

forfeits their right to any prize and the Promoter can draw an alternative winner, via a redraw.
